#### **APPLICATION REPORT**

### **Application Summary**

Armathwaite Play Area Renovation.

Armathwaite Play Area is a 1.3 acre site gifted to the Parish Council by Border Engineering Contractors Ltd in 1981. The play area has historically benefitted children and families from the surrounding communities of Armathwaite, Áinstable, Aiketgate, High Hesket and Low Hesket.

In April 2019 Hesket Parish Council conducted a survey of local residents on the future of the play area. The outcome of the survey highlighted a need to renovate the play area and pointed to key issues and improvement required. The outcome of the survey formed the basis of the Armathwaite Play Area renovation and the following project aims:

- To improve the appeal and usage of the Play area
- To improve access to the play area
- To contribute to community enjoyment of the local environment

The Parish Council agreed that the project aims would be achieved in the following key stages:

- 1. Purchase and installation of new play equipment
- 2. Laying of new and improved footpaths for wheelchairs and pushchairs
- 3. Community led "clean-up" to clear woodland paths, install benches, bird feeders and planting to attract new wildlife.

In October 2019 the Parish Council conducted a consultation on the different design options for a new play area. Following the outcome of the consultation the Parish Council agreed on a final design with a total project cost of £39,750. The Parish Council themselves committed £5000 with the remaining funds to be matched through grants and fundraising.

#### Strategic Fit

This project contributes to Cumbria County Council's vision is the 2018 – 2022 Council Plan: to be "A Council that works with residents, businesses, communities and other organisations to deliver the best services possible within the available resources".
