#### **Variation Sub Committee**

3.1 The Variation Sub Committee will convene as required to consider proposed changes to Health Services as per the first stage of the Committee's Variation Protocol.

3.2 The Sub Committee will meet on Wednesday 21<sup>st</sup> May 2018 to consider whether the proposal from the Cumbria Partnership Foundation Trust to close Flatt Walks Clinic and relocate patients and activity to Cleator Moor Health Centre constitutes a substantial service change.

3.3 The Joint Advisory Group held its development session facilitated by the Cumbria Learning and Improvement Collaborative (CLIC) on the 4<sup>th</sup> May 2018.

3.4 The next meeting of the Group will focus on the Care Quality Commission (CQC) Review of the Health and Care System in Cumbria. To examine the report from the CQC and the planned actions to address the issues it identifies.
