

THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION (NO. 61) (ZONE E REVIEW) ORDER 20<>

1. The Cumbria County Council hereby give notice it proposes to make the above Order under Sections 1, 2, 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 of the Road Traffic Regulation Act 1984.
2. The effect of the proposed Order will be to : -
 - (a) Introduce “No Waiting At Any Time” restrictions on parts of Ashley Street, Bellgarth Road, Bower Street, Brookside, Brookside Place, Canal Street, Clift Street, Cranbourne Road, cul-de-sac nos. 21-39 Brookside, Head Street, Kendal Street, Ruthella Street and Newtown Road, Carlisle;
 - (b) Introduce “Disc Parking, 8 am – 8 pm, Monday to Friday and 8 am – 6 pm, Saturday, waiting limited to 1 hour, return prohibited within 1 hour, (Residents of Zone E Exempt)” on parts of Bower Street, Brookside, Brookside Place, Cranbourne Road, Hawick Street, Lawson Street, John Street, Newtown Road, Peel Street and Ruthella Street, Carlisle;
 - (c) Introduce “Disabled Parking Places, 24 hours a day, 7 days a week, on part of Lawson Street and Kendal Street, Carlisle;
 - (d) Amend the extents of the “No Waiting At Any Time” restrictions on parts of Ashley Street, Bellgarth Road, Bower Street, Broadguards, Caldcotes, Canal Court, Canal Street, Clift Street, Church Street, Cranbourne Street, Granville Road, Lawson Street (North and South of Ruthella Street), Leatham Street, Newtown Road, Queen Street, Rigg Street, Shaddongate, Silloth Street, Wigton Road, Wilson Street and Wood Street, Carlisle, to correct minor anomalies in the existing Order or to accommodate the proposals detailed above.
 - (e) Amend Zone E “Disc Parking Places, between 8.00 am and 8.00 pm, Monday to Friday inclusive, 8.00 am – 6.00 pm, on Saturdays – Waiting Limited to 1 hour, return prohibited within 1 hour”, so that it incorporates the following: -

Ashley Street, Bellgarth Road, Bower Street, Bright Street, Brookside, Brookside Place, Canal Court, Clift Street, Cranbourne Road, Duke Street, Granville Road, Hawick Street, Head Street, Howard Street, John Street, Kendal Street, Lawson Street, Leatham Street, Morton Street, Newcastle Street, Newtown Road (excluding – nos. 63-83), Peel Street, Potters Place, Rigg Street, Ruthella Street, Silloth Street, Wetheral Street, Wood Street, Wilson Street, Wigton Road (part of – 1 to 11), and York Street.
 - (f) Remove the “Disc Parking Places, between 8.00 am and 8.00 pm, Monday to Friday inclusive, 8.00 am – 6.00 pm on Saturdays – Waiting Limited to 2 hours, Return Prohibited within 1 hour” on part of Zone E Ashley Street, Bright Street, Canal Court, Duke Street, Granville Road, Hawick Street, Head Street, Howard Street, John Street, Kendal Street, Leatham Street, Morton Street, Newcastle Street, Newtown Road (excluding – nos. 63-83), Peel Street, Potters Place, Rigg Street, Silloth Street, Wetheral Street, Wood Street, Wigton Road (part of – 1 to 11), and York Street.
